are met by the samples coated with the adhesive grade for the purpose described.

Thus the adhesive AP904 according to the sample material submitted may be safely used for the reverse coating of labels for the labelling of foodstuffs for a storage at room temperature and below. **It may stand in direct contact with dry, moist and non-fatty foodstuffs.**

Furthermore, the adhesive may be used for laminating various materials. In this case, the seams may safely come into direct contact with foodstuffs as far as the adhesive mentioned above is concerned. Precondition is the observance of the migration limit values of the finished product.

The certificate of compliance has a validity of 2 years. It consists of two pages.
